# **ONEX Partner Agreement**

This Partner Agreement ("Agreement") is made between ONEX Affiliate Marketing Services LLC, a company registered in Dubai, UAE (License No.), having its registered office at 3202, Aspin Tower, Sheikh Zayed Road, Dubai, UAE, and the Partner ("Affiliate", "Representative", or "Associate"), who has registered through the official ONEX platform.

# 1. Purpose of Agreement

This Agreement defines the relationship between ONEX Affiliate Marketing Services LLC ("ONEX") and its Partner, authorizing the Partner to promote, refer, and assist in property sales, courses, and travel experiences offered by ONEX. The Partner agrees to represent ONEX professionally and ethically in all dealings with clients and prospects.

# 2. Partner Enrollment & Eligibility

- To become an ONEX Partner, the individual must register via the official ONEX website and agree to this Agreement.
- The Partner must be at least 18 years old and legally eligible to enter into this Agreement.
- Upon registration, the Partner gains access to ONEX's proprietary Affiliate Dashboard, CRM, and marketing tools.

## 3. Packages & Commission Structure

ONEX offers three partner packages:

Essential – \$100: Access to ONEX software tools & dashboard and it includes referral income (Level 1 – 10%, Level 2 – 3%, Level-2%)

Premium - \$500: Includes recognition certificate from Bollywood celebrity in India.

(Level 1 – 10%, Level 2 – 3%, Level- 2%)

Premium Plus – \$1,500: Includes Dubai Tour & Manager Course and it includes referral income (Level 1 – 10%, Level 2 – 3%, Level 3 – 2%)

Exclusive – \$3,000: Includes Europe Tour & Expert Course and it includes referral income (Level 1 – 10%, Level 2 – 3%, Level 3 – 2%)

\$100 from each package is for ONEX software use and platform access. Remaining value in higher packages covers training programs and travel experiences.

#### 4. Commission & Payment Terms

- Commissions are credited automatically upon successful referral packages or property deal closure.
- ONEX reserves the right to hold or adjust commissions in cases of fraud, chargeback, or policy violation.
- Payments are made immediately, within 7 days of SPA signing, after successful deal closure via bank transfer or digital wallet.

#### 5. Visa & Travel Disclaimer

Visa issuance and entry to the UAE are subject to the policies of the UAE government and the immigration authorities of the Client's home country. ONEX is not responsible for any visa rejections, entry restrictions, or delays caused by government authorities. In such cases, ONEX is not liable to issue refunds for the travel or tour components once the booking or processing has commenced.

# 6. Partner Responsibilities

The Partner agrees to:

- Represent ONEX with integrity and avoid false promises or misrepresentation.
- Use only approved marketing materials and content.
- Comply with UAE laws and regulations related to marketing and business promotion.
- Maintain confidentiality regarding ONEX's data, clients, and commissions.

# 7. Use of Branding and Materials

Partners are allowed to use ONEX's brand name, logos, and marketing materials solely for promotional purposes related to ONEX's services and programs. Unauthorized or misleading use will result in immediate termination.

## 8. Confidentiality

All data, client information, and commission reports shared with the Partner remain the sole property of ONEX. The Partner must not disclose or share these details with third parties without prior written approval.

### 9. Termination of Agreement

ONEX reserves the right to terminate this Agreement immediately if:

- The Partner engages in unethical or fraudulent activities.
- There is a breach of confidentiality or misuse of ONEX assets.
- The Partner misrepresents ONEX or its offerings.

Upon termination, all rights, access, and unpaid commissions (if under investigation) may be withheld.

### 10. Limitation of Liability

ONEX shall not be liable for any indirect, incidental, or consequential damages arising from this Agreement or the Partner's activities. The Partner acts as an independent contractor, not as an employee or agent of ONEX.

### 11. Governing Law

This Agreement shall be governed and interpreted under the laws of the United Arab Emirates, and any disputes shall be subject to the exclusive jurisdiction of the Dubai Courts.
